SECTION 5: Fire-fighting measures

5.1. Suitable (and unsuitable) extinguishing media

7.1. Precautions for safe handling

Precautions for safe handling : Do not handle until all safety precautions have been read and understood. For professional or industrial use only. Follow label instructions. 
